In our 37th year of fulfilling our mission, we saw historic impact and commemoration. The year ended with the passing of President Jimmy Carter. His influence and example will be greatly missed, but his mark on our mission will endure.

At the end of 2024 we also completed a three-year strategic vision to provide 300 housing solutions, which included homes built/rehabbed, owner-occupied home repairs for seniors and veterans, and homes provided in our partner countries of El Salvador and Kenya. We completed 134 total housing solutions which tipped us past our three-year goal to a **total of 322 housing solutions**. The total number of households who paid off their loan reached 218.

Beyond providing and preserving affordable homeownership, we know that the stability of a home has many residual impacts. Our latest impact research during this last three-year strategic plan revealed the **positive effects of a stable and affordable home**.

For example, before purchasing through Habitat, only 65% of respondents said their children attended school more often. After Habitat, the number increased to 91%. Before Habitat, 65% of respondents said their children made academic achievements. After Habitat, the number increased to 83%.

None of these accomplishments would have been possible without the unwavering support of our volunteers, donors, and sponsors, whose generosity and dedication continue to propel our mission forward. Our Tiger Team, Young Professionals, and board of directors are consistent servant leaders in our mission.

We are grateful for all who contributed to our impact in 2024 and to exceed our three-year strategic goal. With your support, I am confident that we will continue to make meaningful strides toward our shared vision of a world where everyone has a decent place to call home. **Thank you for your ongoing support and partnership.**

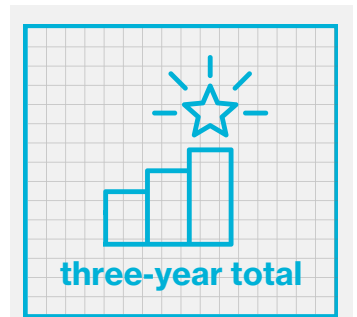
In 2024, we closed out a three-year strategic plan with growth and meaningful impact. The need for attainable homeownership in our region has become increasingly urgent. With 1 in 9 households in Indiana allocating half or more of their income to housing, the mission of Habitat is critical.

Our strategic plan aimed to provide 300 housing solutions: 100 homes regionally, 100 homes repaired, and 100 homes internationally.

Thanks to the dedication of our partners, volunteers, and supporters, we exceeded our ambitious goal.

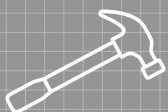

meet Josh & CJ

In the span of 11 months, Josh stepped into a reality he never thought possible – **he became a homeowner.**

Before Habitat, Josh faced obstacles of homelessness, incarceration, and addiction. After overcoming these challenges and years of sobriety, he found a passion for helping others in recovery, working as a mentor and outreach coordinator for recovery housing agencies.

Although he found happiness in his job, he still wanted something that was truly his own and was **ready to find it through homeownership.** He looked forward to the Habitat U classes every week. He found a community in his classmates and learned things he uses in his life today, most recently lessons on estate planning. The day after Christmas Josh lost his stepfather, but he felt relief being able to walk his mom through the process. “I was able to help her in that transition, so the classes were definitely needed.”

Josh felt humbled working alongside volunteers and the Tiger Team to build his home. “Sometimes I look up while watching TV and think about all the people who were willing to be a part of building this with me.” Even his dog, CJ, recognized that this home was right for them.

“During my dedication, CJ kept pulling me into the house. Even he knew this was home.”

Recently, Josh started a new role as a Business Development Coordinator with Sunrise Recovery. He shared how having an affordable and stable home made a huge difference during his career transition.

“It was easy to have faith and feel comfortable because it’s so affordable. I would need a roommate otherwise.”

What more does Josh have planned? Even though he’ll always have a passion for work in recovery, he is thinking about becoming a real estate agent to help others find the same stability he has found through homeownership.

“My serenity is at an all-time high now.”





The Habitat ReStore continues to be a go-to resource for budget-minded shoppers while also serving as a key player in sustainability and community support. Recognizing the growing potential of corporate donations, we opened a new facility dedicated to storage, redistribution, and sale of large commercial donations – a game-changer in improving efficiency and streamlining the donation process. This expansion also allows us to house administrative offices.

According to the latest data from Habitat for Humanity International, Greater Indy Habitat ReStores **ranked 16th among 574 affiliates in gross sales**. This places us in the top 3% of ReStores in the nation for turning donated products into community resources!

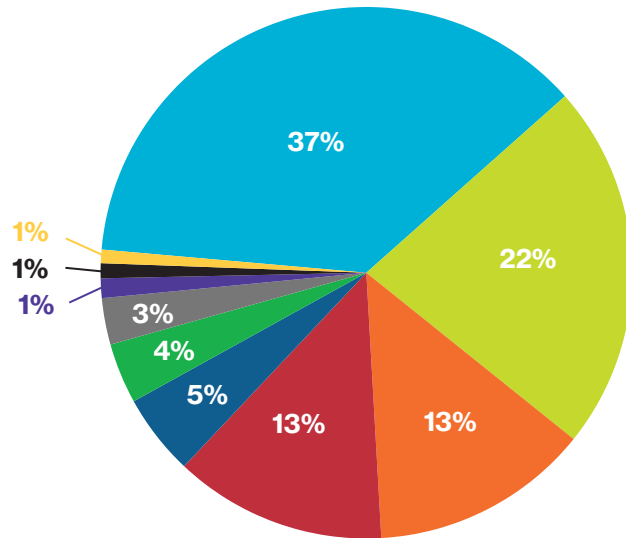

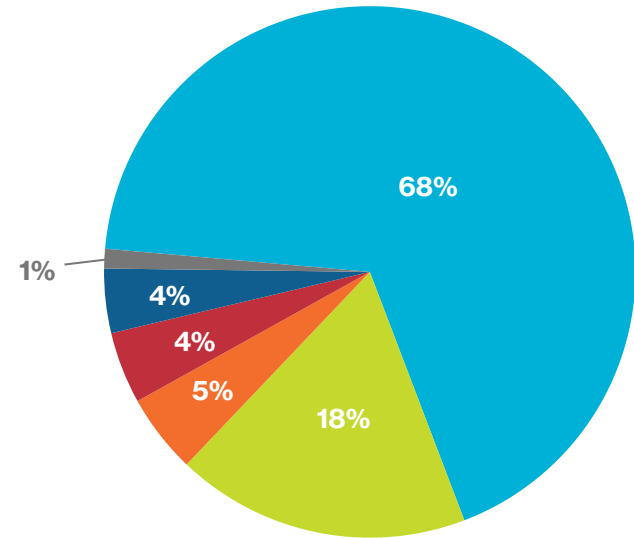
